

# Menu Suggestions

At Kanangra Heights, we are happy to customise the menu to suit your personal tastes and preferences. The following are suggestions only, and we can adjust options to suit your own individual choices. Children are charged according to their ages, which we can address prior to your written invoice.

### Bites In Between

This option allows your guests some nibblies in between your reception and ceremony. We are flexible on choices, but usually it consists of 3-5 of the following choices. These are only to tide guests over until your main reception starts. It also encourages mingling between guests. More options are available, upon request. Wait staff will offer platters of food.

#### Ribbon Sandwiches:

- Cucumber with Cream Cheese herb seasoning
- Curried Egg

- Smoked Ham carved straight off the bone with Jarlsberg Cheese and house made Tomato Relish
- Tung with Mayonnaise seasoned with fresh Dill
- Cheese with house made tomato relish

- Crispy Mini Spring Rolls served with Sweet Soy Dipping
- Celery filled with Gorgonzola and Cream Cheese

### Cocktail

We provide guests the flexibility of selecting their own pizza toppings from our pizza buffet, while our staff cook your pizzas in our wood-fire oven. In between this, we offer a canape service. This is great for a cocktail style setting, or for informal table settings where guests aren't assigned seats. All canapes are prepared on premises.

## Licenced Bar

Most couples provide a bar tab at the beginning of the function, and choose which drinks are covered by the tab. When and if your bar tab is close to finishing, you have the option to top it up or allow guests to purchase their drinks. Chilled water is provided at no cost. Tea and coffee making facilities are available on request.

# KANANGRA HEIGHTS WEDDING AND FUNCTIONS TRADING TERMS AND CONDITIONS



- The following trading terms and conditions apply to the use of Kanangra Heights, being the main grounds, the fixed gazebo and the "Function Centre" for functions. They are to be carefully read and signed upon acceptance.
- 2. Venue Hire Charges Venue hire charges apply to both the grounds and the Function Centre, these are outlined in your quote. When booking for just a meal, 3 hours of venue hire is included in the meal price. If you wish to stay longer than this, a venue hire fee will apply.
- 3. Function Times these will need to be confirmed with Kanangra Heights prior to confirming your booking.
- 4. Wet weather Contingencies In the unfortunate circumstances of bad weather we can provide the veranda, gazebo or main function room as an option for your function. We will make every effort to provide the best alternative, taking into account the number of guests, type of function etc.
- 5. Children are to be directly supervised at all times by a parent or legal guardian during the entire event. Any breakages caused by parents unsatistactorily providing supervision will be invoiced for breakages, damages or cleaning. Children are not permitted to order drinks from the bar (alcoholic or non-alcoholic). Children are to wear shoes at all times. Unless your function has exclusive use of the venue, children are to remain seated with their parents at all times this is to ensure the comfort of other guests. Children are not permitted to make tea or coffee for safety reasons.
- 6. Rubbish Disposal all rubbish is to be placed in the bins provided and any extra-large rubbish items will need to be taken away from the premises for disposal.
- 7. Maintenance of Facilities The customer must maintain the gardens and rooms in the same condition as at the commencement of the event, the customer will be held financially responsible for any repairs, replacements or other loss of damage caused by the customer, their guests, employees, contractors, patrons, or any other third party persons associated with them.
- 8. Displays and Signage Nothing is to be nailed, screwed, stapled adhered or otherwise affixed to any wall, door, surface or part of any internal or external of the building or any trees/plants in the garden.
- 9. Confirmation of Bookings -Signed paperwork and a deposit of 20% of estimated numbers is required to confirm the date requested.
- 10. If the customer does not meet payment terms and dates Kanangra Heights retains the right to terminate the agreement without notice and release the date for alternative bookings.
- 11. The deposit will be based on the estimated number of guests and will be subtracted from the final invoice.
- 12. Cancellation or postponement must be submitted in writing.
- 13. Kanangra Heights reserves the right to allocate the date to another party until the deposit is paid.
- 14. All fees are considered unpaid until funds are cleared and accessible by Kanangra Heights.
- 15. The remaining balance plus any extra items including but not restricted to decoration packages and bar tabs are payable three weeks prior to date of event.
- 16. If event is cancelled at any time between the date of the event and three weeks prior, no refund will be given.
- 17. If the event is cancelled at any time greater than three weeks prior to the event, but less than 120 days prior to the event, 100% of the deposit will be retained.
- 18. If the event is cancelled prior to 120 days before the event, 50% of the deposit will be retained.
- 19. Any expenses incurred by Kanangra Heights over and above the deposit amount will be invoiced to the customer and are payable within 14 days.
- 20. Any additional charges incurred at the event must be paid the on the day of the event. Kanangra Heights will not invoice for goods and services post event.
- 21. Taxes All our pricing and charges include goods and services tax.
- 22. Confetti No throwing of confetti or rice is allowed on the grounds of Kanangra Heights, only rose petals are allowed to be thrown, if confetti is thrown a \$500.00 charge will be applied for cleaning.
- 23. Smoking Kanangra Heights is a licenced venue & as per local laws, there is no smoking within any area where food or drink is consumed. This includes the veranda, grassed are surrounding the function centre and the grassed area on the pool terrace. Smoking is also not permitted in the car park. The only place smoking is permitted on the grounds is in the designation.

nated outdoor smoking area (DOSA) which is to the side of the turnaround area. There are ashtrays provided for disposal. If cigarettes are thrown onto the ground, then a \$500 cleaning charge will be applied.

- 24. Last drinks- Staff will call "last drinks" at 11:30pm. All guests must leave the premises by 12am. This is in line with our QLD liquor licence. No exceptions will be given, due to disturbances of neighbouring properties. We ask that guests leave in a respectful manner.
- 25. Kanangra Heights holds a zero-tolerance approach to abusive or inappropriate behaviour by guests, 3rd party employees or any visitors. This includes drunk or antisocial behaviour. As our duty of care to keep guests safe, and in
- 26. accordance with our liquor licence, we may ask persons to leave the premises, and in extreme cases, we reserve the right to terminate your function immediately. Taxis, police or security will be called to remove guests, at your cost.
- 27. If you require extra security, this can be provided at cost to you, on request to management.
- $28.\ \mbox{All}$  quotes and prices given are confidential, along with any personal information collected.
- 29. Swimming is prohibited by wedding guests in either the dam or swimming pool. Children especially, need constant supervision whist in these areas. Both areas are strictly off limits for safety purposes.
- 30. Kanangra Heights staff reserves the right to stop serving alcohol to anyone that they deem has had too much to drink or that they deem is acting in an abusive or unacceptable manner. Kanangra Heights reserves the right to ask guests to leave if they deem the person or persons are not acting within the terms and conditions of Kanangra Heights.
- 31. Alcohol Kanangra Heights is a fully licenced venue & as such, there is no BYO alcohol permitted. This includes the car park area. Any person found to be providing their own drinks will be asked to leave the venue immediately.
- 32. Indemnity to Kanangra Heights The customer indemnifies Kanangra Heights to the fullest extent of the law from and against 1. All claims, demands, writs, summonses actions, suits, proceedings, judgements, orders, decrees, damages, costs, losses and expenses of any nature which Kanangra Heights may suffer or incur in connection with the loss of life, personal injury or damage to the property incurred or suffered directly or indirectly in connection with this agreement, the use of facilities by the customers, its servants, officers, contractors, guest, members, patrons and invitee's or any other person associated with them except where such injury, loss or damage arises by reason of an act or omission of Kanangra Heights staff, or its agents or subcontractors. 2. Kanangra Heights is not liable or responsible to the costumer or any servants, offices, contractors, guests, members, patrons and invitees or any other persons associated with them for any loss of life, personal injury or damage to or loss of property which may be suffered at any time of the facilities except where such injury, loss or damage arises by reason of an act or omission of Kanangra Heights staff, employees, agents or subcontractors.
- 33. Premature Termination Kanangra Heights shall be entitled to cancel the contract without notice if; (a) The customer fails to fulfil any of its obligations laid down in the contract, including, but not limited to, payments. (b) The customer alters the purpose of the function without the approval of Kanangra Heights management. (c) Kanangra Heights becomes aware of conditions under which the execution of the function could jeopardise public safety or order, or potentially involve an unacceptable risk of personal injury or damage to property.
- 34. The basis of this agreement and performance of Kanangra Heights is contingent upon the ability of Kanangra Heights to complete the same, and is subject to labour troubles, disputes, strikes or picketing, accidents, governments requisitions, restrictions upon travel, transportation, food, beverages, or supplies, equipment failure, and other causes wether enumerated herein or not, which are beyond Kanangra Heights control. In no event shall Kanangra Heights' liability be in excess of the total amount of the food and beverage contracted heretofore.
- 35. We seek permission to use any photos taken at Kanangra Heights for promotional purposes, or use on social media. This may include professional photos, people themselves, children (although we try to avoid photos of children, we will make efforts to seek children's guardian's permission), set up, staff, grounds, external clients etc. If you would rather we didn't, please let us know.
